Instructions:

- In Column B, select your Planning and Service Area (PSA), using the button selector on the top left to enter the information for each county in the PSA.
- In Column D, enter all townships, communities, or neighborhoods that can be considered as unserved areas for each county in the PSA. If all areas of the county are being served, **enter "N/A."**
- In Column E, enter the estimated number of older persons needing home delivered meals in each county of the PSA.

Note: "Unserved Area" is defined as geographic areas (e.g., rural township areas or neighborhoods in cities, etc.) that are not served by the home delivered meal program due to lack of funding OR the need for additional volunteers to deliver the meals.

Congregate Meals: Hot, Cold & Frozen Meals

Instructions:

- In Column B, select the PSA.
- In Column C, enter the names of the nutrition programs for the PSA.
- In Column D, enter the number of hot congregate meals served by each nutrition program in FY 2021.*
- In Column E, enter the number of cold congregate meals served by each nutrition program in FY 2021.
- In Column F, enter the number of frozen congregate meals served by each nutrition program in FY 2021.
- In Column G, the sum will automatically total Columns C-F.
- **Enter a "0"** for a type of congregate meal (i.e. Hot, Cold, Frozen) **in which no meals of that type were served** by the nutrition program.

For Additional Rows: If you need additional rows for your nutrition programs, make sure you are on the "Home" tab at the very top of the Excel document, then hover over and click on the number on the left side of the Excel document to highlight the entire row that you would like to insert another row above. Click on the "Insert" tab at the very top right side of the Excel document and then click on "Insert sheet rows."

Note: For Columns D, E, and F the number of meals served should be based on period from October 1, 2020 to September 30, 2021.**

*As a reminder, all “take out” or “to-go” meals regardless of Hot, Cold, or Frozen that were provided to Congregate Meal participants during the pandemic cannot be counted as a Congregate Meal and must be counted as a Home Delivered Meal, unless the meals were consumed with another congregate meal participant “virtually” through an approved program in that PSA.

- In Column C, enter the names of the nutrition programs for the PSA.
- In Column D, enter the number of hot home delivered meals served by each nutrition program in FY 2021.
- In Column E, enter the number of cold home delivered meals served by each nutrition program in FY 2021.
- In Column F, enter the number of frozen home delivered meals served by each nutrition program in FY 2021.
- In Column G, enter the number of shelf stable home delivered meals served by each nutrition program in FY 2021.
- In Column H, the sum will automatically total Columns D-G.
- In Column I, enter the total number of home delivered meals that were considered "take out/to-go" meals.*
- **Enter a "0"** for a type of Home Delivered Meal (i.e. Hot, Cold, Frozen, Shelf-Stable) **in which no meals of that type were served** by the nutrition program.

For Additional Rows: If you need additional rows for your nutrition programs, make sure you are on the "Home" tab at the very top of the Excel document, then hover over and click on the number on the left side of the Excel document to highlight the entire row that you would like to insert another row above.
