At the January 3, Decatur City Council Meeting, the council approved the recommendation to increase Dove's contract for COVID-19 rent and utilities assistance with an additional \$300,000. This funding, from the City of Decatur, is only available to residents and will be distributed through DFA, Dove Financial Assistance Program.

Through the end of 2021, Dove has expended over \$400,000, helping 160 families with rent and utilities. There is a particular need for the working family that must stay at home with their children because of COVID exposure or due to having COVID. We see families who live paycheck to paycheck so losing even a week's income puts them behind. For families who have multiple children, this is particularly hard when you must take off work multiple times. We have talked to landlords who have also struggled during this pandemic but continue to try to work with their tenants to keep them housed. These funds can help ease this burden on landlords.

CLFRF Program Guidelines

1. Eligible applicants may receive rental and mortgage assistance up to 14 months (includes 2 months paid forward).
2. Eligible applicants may receive power/utility assistance up to 12 months, excluding water.
3. Each eligible household may be funded not to exceed \$15,000.00.
4. Eligible residents must reside within the City of Decatur, IL corporate limits.
5. Eligible applicants may only receive assistance from one Agency for one time period, other assistance can be received for other time periods from other agencies.
6. Eligible applicants must show proof of hardship.
7. Eligible applicants must not exceed the City of Decatur's FY 2021 Median Family Income based on statistical calculations by U.S. Housing and Urban Development (HUD).
8. Assistance must result in applicant staying in their housing for a minimum of 60 days.
9. Landlords are eligible to apply for assistance.

- Landlord Agreement (part of the application)

2021 has come and gone and in some ways, it feels like a whirlwind and in another it feels like it lasted forever.

It was another rough year

for so, so many, for a myriad of reasons, the ongoing pandemic obviously one of the top ones. Financial difficulties, increases in crime and domestic violence, anxiety, depression and other mental health issues, social isolation, and loss are just a few examples of things that have impacted everyone in the last couple of years.

Christmas is always a challenging time for many and when compounded with all these other factors, is extra trying. We had more people signed up for Christmas assistance this year than ever before. Still partnering with Northeast Community Fund, Salvation Army and Toys for Tots enabled us to serve 836 families with toys for their children in 2021, which equaled 2,458 children receiving toys and gifts.

None of us could have pulled that off without the generosity of every single person who donated toys, wrapping paper and tape, hygiene items, money, stockings, hats and gloves, and the gift of your time for those who volunteered. We had 79 individuals who volunteered their time to help with Christmas Care & Share, who spent nearly 800 hours of time in the two weeks

we were there. There are not enough words to express my sincere gratitude to every single one of you, as well as every single person from Dove staff who came and helped.

The counting and sorting of toys and items are time-consuming and sometimes tedious but you answered the call. Helping man the toy stations and help the families shop is another big job – and you answered that, too. Thank you.

A HUGE thank you goes out to everyone at St. Paul's Lutheran Church for being gracious and thoughtful hosts who went well above and beyond answering the call when it came to helping, providing lunch for staff and volunteers one day during distribution, preparing and passing out snacks and drinks for staff, volunteers, and people receiving gifts for their children throughout distribution week, and greeting and guiding people around the church to help them find their way. An extra big thanks to Mick who was our point of contact from St. Paul's who helped us get set up and organized, many times going as far as to help unload and haul donations around to get them where they needed to go.

I would be remiss in not mentioning Pawprint Ministries for bringing several of their comfort dogs through to mingle with staff and individuals who were there during distribution week. It was a huge success, and they brought Santa Claus with them to visit with folks, as well. Thank you to all of



you for your kind spirit and generosity!

I wish I could mention every single person who helped and donated but there are so many people and I don't want to forget anyone, so please know we appreciate you!

I also want to thank our Care & Share Committee for all their hard work going all the way back to April of 2021 when we began planning and organizing things: LeAnn Ellis, Kathy Walters, Jennifer Tolladay, Diana Guidebeck, Patty Cain, Melissa Girardi, Daciena Simmons, Maddie Meyer, Brandy Robinson and Joey Skelton. You are all amazing and we could not have pulled things off without you. I thank God for you all every day.

Always thanks to our partners: Northeast Community Fund, Salvation Army, and Toys for Tots.

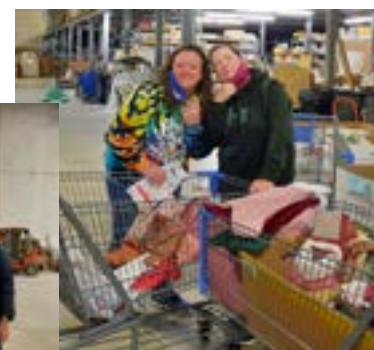
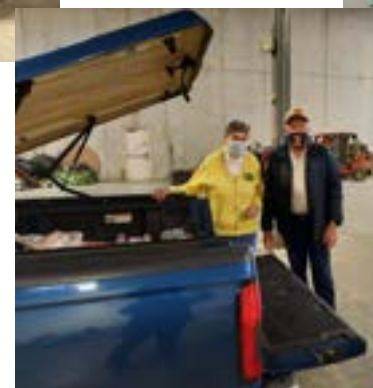
My heart is full the way it is every year when the community turns out and goes beyond themselves to serve those who are most in need in Central Illinois at Christmas time. Bless you all.

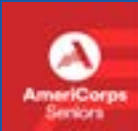

Meet Angie Williams RSVP/SCP Program Director

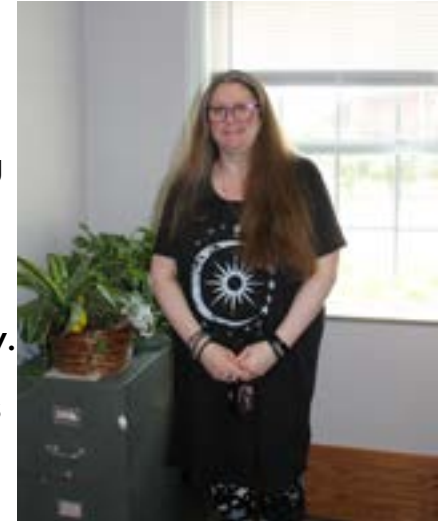

News from Homeward Bound

Staff have been working to engage and house 17 individuals who have been literally homeless (in a shelter, on the streets or somewhere unfit for human occupancy, such as an abandoned building) for 90-days or more. Four of those individuals meet the chronically homeless criteria, which means they have a diagnosable disability AND have been homeless for at least 1 year or have been homeless 4 times in the past 3 years, totaling 365 days.

There are 825 total participants currently receiving housing and/or services.

The need for 1-bedroom units for single individuals is still dire!

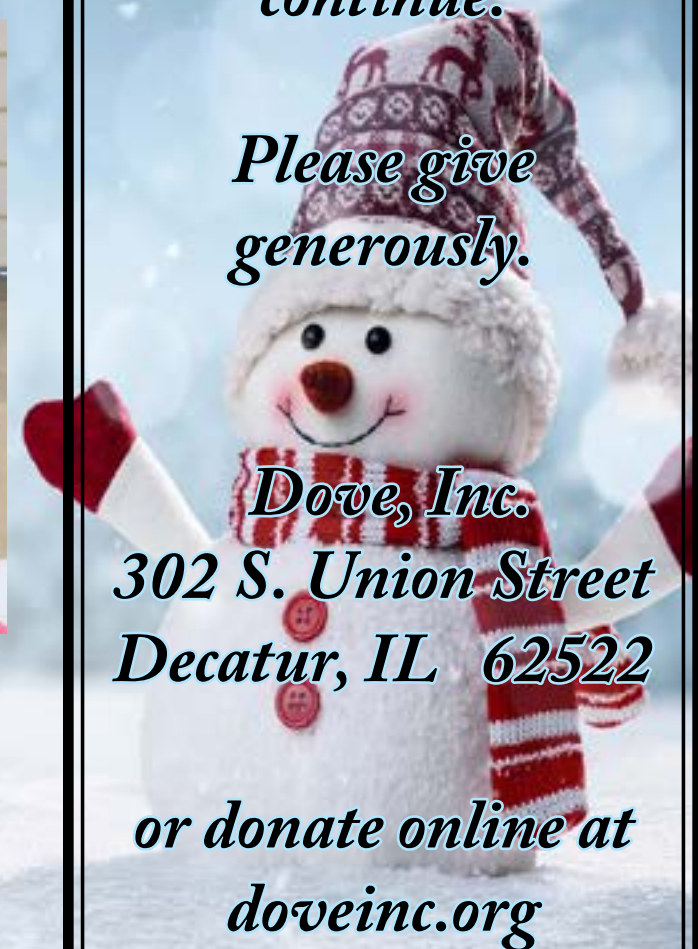
