Medicaid Non-Emergency Medical Transportation

If you receive Medicaid benefits and need non-emergency medical transportation, contact **First Transit** at 877-725-0569 to help find a transportation company and get your trip pre-approved through Medicaid. First Transit will ask:

- Your name
- May need to get your "OK" to talk with the person calling for you
- Your pick-up address and phone number
- Your Medicaid ID# (9 digit recipient identification number)
- The general reason for your doctor's visit
- The name of the office/clinic /hospital where you are going
- The name of the doctor you will be seeing
- The address and phone number where you are going
- The appointment date and time
- If there are medical or non-medical reasons why you cannot use public or other transportation
- If you use a walker, wheelchair, or cane
- If you can travel by yourself

First Transit will give you a reference number. Call the transportation company and give them your reference number and schedule your pick-up time. Call the transportation company before your doctor's appointment to confirm your reservation.
